

**POST® KICK OFF SUMMER SWEEPSTAKES**  
**OFFICIAL RULES**

- 1. SWEEPSTAKES PERIOD:** The Sweepstakes begins on May 21, 2017 at approximately 12:00 PM Eastern Time ("ET") and ends on June 18, 2017 at approximately 11:59:59 PM ET ("Sweepstakes Period"). Administrator's computer is the official clock of the Sweepstakes.
- 2. ELIGIBILITY:** This Sweepstakes is offered only to legal residents of California, Colorado, Connecticut, Delaware, Idaho, Maryland, Montana, Nebraska, Nevada, New Jersey, New Mexico, New York, Oregon, Pennsylvania, South Dakota, Texas, Utah, and Wyoming who are eighteen (18) years and older at the time of entry. Employees of Sponsor, Administrator, and each of their respective parent companies, divisions, dealers, affiliates, subsidiaries, distributors, advertising and promotional agencies and suppliers involved in the Sweepstakes ("Sweepstakes Entities"), as well as the members of each of their immediate families (spouse, parents, children, siblings, and in-laws) and persons residing in the same household as such individuals are not eligible to enter or win.
